MAP is CCSNJ's program designed to help members get in touch and do business with each other. We offer our members the opportunity to access fellow member companies through our Database and Fax Programs, as well as mailing labels.



Database Program

One-time Database Program enrollment fee\$250.00 + \$17.50 tax = \$267.50

- ◆ Excel database records include: main contact name, company, address, phone number, number of employees and business classification.
- ◆ The enrollment fee enables your company to access database updates as long as you remain a chamber member in good standing.

Database Updates \$75.00 + \$5.25 tax = \$80.25

Chamber Fax Program

One page instant fax mailing to Chamber Members\$350.00 + \$24.50 tax = \$374.50

- ◆ Must be one minute or less with limited shading and graphics.

Pressure-sensitive label set for the main company representative only
\$125.00 + \$8.75 tax = \$133.75

Pressure-sensitive label set for all member company representatives
\$175.00 + \$12.25 tax = \$187.50
