DECK & WOOD Coating Rejuvenator

DESCRIPTION

DWR Coating Rejuvenator is a concentrated product for cleaning, restoring and brightening exterior, natural wood decks and siding. Coating Rejuvenator can also be used for heavy duty jobs such as concrete etching and rust removal from driveways and stucco. Other uses include: paint prep cleaner, mill glaze removal and cleaning vinyl and aluminum siding. This product does not contain any bleach, chlorinated solvents, caustic or any ozone depleting ingredients.

USES

Use Coating Rejuvenator in place of ineffective bleach products or hazardous solvent based compounds. It is a proven cleaner/restorer for greying and discolored wood, mill glaze removal, concrete etching and vinyl and aluminum siding.

PREPARATION & APPLICATION

Coating Rejuvenator can be applied by brush, roller or pump-style sprayer. Prior to application, remove all furniture and children's toys from the area. Thoroughly wet down plants and vegetation before and after application to avoid damage. Do not apply to hot surfaces or in direct sunlight. Apply to a cool, dry surface. Apply Coating Rejuvenator liberally to the surface with recommended applicator. On vertical surfaces, start from the bottom. Agitate surface and rinse or power wash. If cleaner dries, mist with water or re-apply cleaner. Re-apply if necessary to achieve desired results.

TEST AREA:

Before general use, it is imperative that a small test be done, typical of the surface to be cleaned to determine compatibility.

DISPOSAL

SAFETY
