Valley Forge National Historical Park Adds New Free Shuttle Service

As traffic congestion, pollution, and driver frustration continue to grow on roads all around Valley Forge National Historical Park, the park is trying out a new way to keep the park quiet, safe, and green. This summer, the park is experimenting with a free shuttle among the most popular destinations to give visitors an alternative to driving.

Beginning on May 16, visitors will be able to park their cars and step on board The Revolutionary Shuttle. The six-mile loop runs throughout most of the park, and riders can hop on or off at any of nine stops, including the Welcome Center and Washington's Headquarters.

The colorful shuttles, wrapped with images of Continental soldiers, will come along every 15 to 20 minutes, so visitors can take their time at any destination without worrying about meeting a schedule. The shuttles carry bike racks, so visitors can combine a bike tour with an easy ride. Partially fueled by bio-diesel, the shuttles will reduce congestion, noise, and emissions in the heart of the park.

This year's shuttle service is an experiment. Park staff will be on hand to reach out to visitors to find out what they do and don't like about the service, and will tweak it throughout the summer to find the best fit. "The Revolutionary Shuttle is a great new addition to the growing menu of visitor services at Valley Forge," said park superintendent Mike Caldwell. "We're experimenting with the service this summer, and if visitors are enthusiastic we'll expand it next year."

The Revolutionary Shuttle is the latest in a variety of fun, convenient ways to see the park. The popular 90-minute guided Trolley Tour already is running. Trolley Tour riders hear the full story of the Valley Forge Encampment and enjoy the expertise of a professional guide on an open-air trolley, with extended guided stops at Washington's Headquarters and Muhlenberg's Brigade.

Visitors also can walk, bike, or ride horses on some of the park's 26 miles of trails. Bike rentals are available at the Lower Welcome Center parking lot.

The shuttle is funded through National Park Service Alternative Transportation Funds, and a grant from the Ford Motor Company through the National Park Foundation. Greater Valley Forge Transportation is providing management services.



Member Spotlight

20 Years of Service to Montgomery County

RT Environmental Services, Inc. (RT), headquartered in King of Prussia, celebrated its 20th Anniversary in 2008. Gary R. Brown, P.E., President, and Walter Hungarter, Associate, participate in MCIDC functions and seminars to make sure that MCIDC members have the latest information on how environmental issues may affect members' properties or commercial or industrial operations.

The firm also recently announced an expansion to Southwest Pennsylvania, and has opened an office in Washington, PA, a short distance southwest of Pittsburgh. The firm also maintains a New Jersey office to service business and industry in the Garden State.

In addition to having Environmental Engineers and Geologists on staff, the firm offers expertise in environmental science, asbestos, lead paint, mold investigations, and remediations. Several years ago, the Pennsylvania Department of Environmental Protection tallied the number of completed Act 2 Land Recycling projects, and RT had the most in the state. Act 2 Land Recycling Sites are typically Brownfield sites, and the award winning Act 2 Program was considered a "breakthrough program", when it was put forth in the 1990s. Many Montgomery County site owners have taken advantage of the program, so that sites can be reused cost effectively, through the DEP Liability Release signoff on cleanup activities.

The firm also features a quarterly newsletter, the RT Review. The firm has also recently started an Email Blast Service, and RT's webpage is linked to the MCIDC webpage. RT's principals regularly participate by providing articles, and presenting seminars to MCIDC members.

According to Gary R. Brown, President of the firm, current issues important to the commercial and industrial business community include:

-Federal Spill Prevention Control and Countermeasure Regulations were recently finalized, but, extensions in compliance dates have left a number of owners and operators of establishments confused. Most provisions of the new rules are effective on July 1st, so now is the time for everyone to update their Spill Prevention Control and Countermeasure Plans.

-Vacancies in commercial and industrial space mean that many properties have to be "mothballed", in whole or in part. Mothballing is important to protect asset value and avoid later problems with mold and/or asbestos. Information on mothballing was presented at an MCIDC seminar in late winter, and key information is available on RT's webpage at www.rtenv.com.

-Stormwater management is also important, and there have been a number of updates which allow sites to be developed or redeveloped more cost effectively, more so then even in the recent past. Reevaluation of site plans which were prepared as little as three years ago, can yield significant savings, as updated technologies and approaches for implementing stormwater best management practices are now possible at many sites.

-RT is also helping many owners with infrastructure funding and grants, including funding to facilitate redevelopment at Brownfield Sites, including Superfund sites, in Pennsylvania and New Jersey. There are many grant and loan funding options currently available for remediation and redevelopment projects and RT has worked with MCIDC on any number of projects over the years, to help potential redevelopers determine their best options going forward.

In 2009, the firm expects to expand further into wetlands work, and to continue to cross train its staff so that the Environmental Site Assessment Due Diligence process which precedes property transactions can be completed as cost effectively as possible.
